By signing below, I agree that:

- 1. I have voluntarily decided to participate in activities and events at, and use the facilities of, STONE EDGE SKATEPARK, which is owned and operated by Stone Edge Properties Inc. (STONE EDGE).
2. I am voluntarily participating with the knowledge of the numerous risks and dangers involved, including but not limited to: physical exertion for which I may not be prepared; consumption of alcoholic beverages; breakdown of equipment, whether rented or owned; accident or illness; the risk of negligence by myself or others, including Stone Edge Properties Inc. and/or Dawn Allen Inc.; and the potential for serious injury, including permanent paralysis or death.
3. I will follow all written and verbal rules of safety presented to me by STONE EDGE.
4. The enjoyment and excitement of skating and biking is derived in part from the inherent risks associated with an activity that is beyond the generally accepted margins of safety, and that these inherent risks contribute to such enjoyment and excitement, and are one the significant reasons for my participation.
5. I am responsible for my own welfare and accept any and all risks of unanticipated or anticipated events, illness, injury, emotional or physical trauma or death.

One of the conditions to entering Stone Edge Skatepark and using its facilities is my execution of this Waiver; therefore, as lawful consideration for being permitted to enter Stone Edge Skatepark and use its facilities, I hereby RELEASE AND DISCHARGE FOREVER STONE EDGE, ITS SHAREHOLDERS, DIRECTORS, OFFICERS, AGENTS, EMPLOYEES, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND THE OWNERS AND LESSORS OF PREMISES USED TO CONDUCT A STONE EDGE RELATED EVENT ("RELEASEES"), FROM AND AGAINST ANY AND ALL LIABILITY ARISING FROM MY USE OF STONE EDGE SKATEPARK OR PARTICIPATION IN ACTIVITIES OR EVENTS AT STONE EDGE SKATEPARK.

This release shall be legally binding upon me personally, all members of my family and all minors accompanying me, my heirs, successors, assigns and legal representatives, it being my intention to fully assume all of the risks associated with my use of Stone Edge Skatepark facilities and to release RELEASEES from any and all liabilities associated with my use of Stone Edge Skatepark facilities to the maximum extent permitted by law.
8. I understand that STONE EDGE reserves the right to refuse admittance to any person who refuses to sign this Waiver or who it judges to be incapable of meeting the rigors and requirements of participation in the activities.

STONE EDGE, its agents, successors and/or assigns, reserve the right to take photographic, film, audio or digital records of me using Stone Edge Skatepark facilities or participating in events or activities sponsored by STONE EDGE ("Stone Edge Media"), and I further agree that STONE EDGE may use any such Stone Edge Media for promotional and/or commercial purposes, as well as approve such use by third parties with whom STONE EDGE may engage in joint marketing, without any remuneration to me. I hereby assign STONE EDGE all right, title and interest I may have in or to Stone Edge Media and grant STONE EDGE a royalty-free, exclusive, perpetual and irrevocable license to the Stone Edge Media.

I agree that any dispute or claim concerning this Agreement, shall be resolved exclusively by binding arbitration according to the then existing rules of the American Arbitration Association in Jacksonville, Florida. Florida law shall govern this Agreement, excluding any application or consideration of any conflict of laws provisions.
